Matters Arising:

Election of Vice Chairman – Mr S Hulme was elected to the position of Vice Chairman, being nominated by Mr D Leech and seconded by Mrs P Massey

Admaston Conservation Area - The Chairman welcomed Greg Hall, Anna Miller and Emily Christie. Councillor Hall gave a brief resumé on how ESBC responded to planning applications. The Vice Chairman posed a question to the Planning Department team regarding on what grounds planning applications could be supported or objected to. The ESBC Planning Department say that there has to be material planning considerations. The scope of what can constitute a material consideration is very wide and so the courts often do not indicate what cannot be a material consideration. However, in general they have taken the view that planning is concerned with land use in the public interest, so that the protection of purely private interests such as the impact of a development on the value of a neighbouring property or loss of private rights to light could not be material considerations. Retrospective planning applications are treated in the same way. Although we are encouraged to comment on any planning application, ultimately all decisions are made according to the Local Plan. In reply to a question on the local conservation area we were informed that there had been no review of Admaston as there was no Conservation Officer on the team, but hopefully a review would take place in the near future.

Neighbourhood Plan – After an in depth discussion between Councillors and the ESBC Planning Department team, the Vice Chairman agreed to liaise with them regarding the setting up of a Blithfield Parish Plan and may be organising a visit to a similar parish that already had a neighbourhood plan.

Local Government Transparency Code – It was reported that we had been successful in our bid for £1,229.
