Matters Arising

The Chairman welcomed Lucy Hadfield, Police Constable Support Officer, who informed us that, as well as Blithfield, she covered Uttoxeter, Kingstone, Barton and Marchington. In answer to concerns of Councillors regarding speeding on the roads throughout the Parish, she advised the meeting that efforts were being made to mobilise a Speed Camera Team to monitor the area and hopefully this would take place in the new year. The subject of aggressive speeding aggregate lorries on the B5013 between the reservoir and Colton (particularly through Admaston and the bends at Hamley Heath) was a major concern to locals. She said that the police were aware of the problem but she was unable to offer any solution at present. Admaston Telephone Kiosk – The Clerk reported that she was awaiting a reply from BT regarding the purchase of this kiosk.

Admaston Notice Board – After discussion it was agreed to purchase a new notice board from a local company for around £200
