Colton Parish Council – Gulley emptying. After asking for an estimate of costs in joining them in sharing facilities, it was learned that at this stage it was just a general enquiry.

VE Day 2020 Celebrations – The Chairman updated the meeting of the arrangements made to date.

Planning Applications

P/2020/01105 Retention of 2 metre high fencing, static caravan and porta cabin, Leaway, Lea Lane, Newton, WS15 3NR — Greg Hall explained how planning applications were processed within ESBC Development Control Department. He subsequently answered questions from the floor. Blithfield Parish Council has a number of issues with this application, namely, that the fence appears to be more than 2 metres high and with an earth bank beneath makes it even higher; there is insufficient space left to plant a hedge as it would interfere with visability and reduce the width of the roadway; has permission been granted for the three bedroom mobile home to be connected to a septic tank that is presently shared with the adjacent property; is a business being undertaken on the site as a number of commercial vehicles are parked there at night; complaints have been received by residents regarding the unsightly look of the site in such a rural area. Blithfield Parish Councillors unanimously objected to this application.

HS2 – It was agreed to invite a representative from HS2 to attend a future Parish Council meeting. Planning Application P/2020/00022 Crown Reduction of 7 Cherry trees and 2 Silver Birch trees to a height of 8.2 metres, Admaston Farmhouse, School Lane, Admaston – The Vice Chairman drew attention to the decision by ESBC not to allow this planning application to go ahead even though the Parish Council and the nearest neighbours had no objection. It was agreed to contact ESBC to establish why it had made this decision.
