#### **DRAFT** Minutes of the Ordinary General Meeting dated 12.01.2023

**23.01.01** Apologies: for Absence: No apologies were received.

The Chairman welcomed the councillors and members of the public to the meeting.

**23.01.02** Minutes of last Meeting held on 10.11.2022 were resolved and signed.

23.01.03 To receive declarations of interest by members in respect of items on the agenda. There were none.

**23.01.07** (this item was brought forward in the Agenda) Mr Jon Wood who is kindly coordinating the roll out of Superfast Broadband in the parish attended the meeting and updated us on the project so far. Phase 1 is now complete, this includes the area of Dapple Heath, Newton and Stansley Wood. There have been some teething problems but in general it has been successful.

There has been a delay in starting phase 2, which is the area of Admaston as the government changed the scheme. The cost of phase 2 is approximately double that of phase 1. It, going ahead is once again, however, dependant on enough residents of Admaston pledging to use the vouchers which the government are offering, to households to cover the cost of the work.

Jon is at present validating the list of households he has, for Admaston, so that he can contact each one, and hopefully get the necessary pledge. From acceptance of Admaston for the upgrade, until installation commences is about 12 months.

The parish council are extremely grateful to Jon for his assistance and the chairman thanked him.

### 23.01.04 Matters Arising from the Minutes

- a) Unregistered land adjacent to B5013 and reservoir The clerk has written to South Staffs Water regarding the ownership of land. A reply has been received from Richard Whiting who indicated that South Staffs Water owned the land and would not want to close it for car parking as this would mean others could not enjoy the views etc. A meeting has been requested and we have so far had no response.
- b) The 2 Oak Trees have now been planted in Blithfield Park, one for the Platinum Jubilee of Queen Elizabeth II and one for the Coronation of Charles III. It was agreed to have a commemorative plaque for each tree that can be screwed to the tree guard.
- c) Lea Heath Junction contact has been made with the Hixon parish clerk regarding the new road layout at the junction to Hixon. The changes have been planned for 9 years and have had the desired effect of slowing traffic down. Our concerns of the problems created for larger vehicles at the new junction and several accidents were raised. A bollard is to be erected on the built out grass verge and 'change of road layout' signs are also planned.
- d) Coronation the celebrations will take place on Monday 8 May 2023 at Adamston village hall. The hog roast has been ordered. A quotation of around £1000 including VAT has been received for the marquee. A suggestion was

made to have an extra bay on the marquee. A committee will be formed to plan further along the lines of the Platinum Jubilee Celebrations. There are to be no beacons for the Coronation.

e) Parish boundary signs – there is doubt whether these are practical due to the demographics of the roads in the parish but we will keep this item on the agenda for further consideration.

### 23.01.05 Clerk Update

- a) The Civility and Respect Pledge The parish councillors unanimously agreed that Blithfield Parish Council should make this pledge.
- b) Elections It was agreed that the clerk should attend the SPCA online training course for election training. The cost is £30 plus VAT.
- c) The parish laptop has been serviced and is running well. It should not need replacing. However the quality of print on the printer is deteriorating so that may need replacing in the next financial year.
- d) The chairman and clerk will work together to produce a parish newsletter in the next few weeks.
- e) It was agreed to adopt the 45p/mile rate for the parish clerk's travel expences which is suggested by the SPCA.
- d) Solar Farm Drointon the chairman, the clerk and some parish councillors attended the community consultation event. It is government policy to install these solar farms so there is little point in opposing it but we will monitor it.
- **23.01.06 Public Participation.** The problems with water on Booth Lane were raised again. Both the issue at Heath Lane and the one at the Booth have been reported to Highways. No response has been received. The owner of the land adjacent to Heath Lane has been contacted twice with regards to digging out the ditch in his field. His response was that he was waiting for a suitable digger. The gullies in both locations need to cleaning out too.

Defibrillators have been received from Welmedical to be used while ours are being serviced. The pads need replacing by the end of May 2023.

- b) Admaston Lay-by the request for white lines and a giveway sign have both been turned down. Whilst other white lines in the parish have been renewed recently, these have not. Communication with Cllr Philip Atkins will be made to apply further pressure to get something done here.
- c) Admaston Telephone Box the parts have now been received and are with Cllr K Massey. The insurance money has been received.
- d) Booth Lane Both locations where the gullies need emptying have been reported to Highways.
