## Minutes of the Ordinary General Meeting dated 02.03.2023

23.03.01 Apologies: for Absence: No apologies were received.

The Chairman welcomed the councillors to the meeting

**23.03.02 Minutes of last Meeting** held on 12.01.23 were resolved and signed.

**23.03.03** To receive declarations of interest by members in respect of items on the agenda. Cllr Hulme declared an interest in planning application P/2023/00131.

### 23.03.04 Matters Arising from the Minutes

- a) Unregistered land adjacent to B5013 and reservoir A meeting has been arranged on this land with Richard Whiting of S.Staffs Water and the Admaston Councillors.
- b) The Jubilee and Coronation Oaks The commemorative plaques are ready to be attached to the tree guards.
- d) Coronation a Coronation planning meeting has taken place, the celebration will take place at Admaston Village Hall commencing from 3pm with childrens' games, crafts and a best crown competition. This will be followed by a hog roast and entertainment by Lola Lamour.
- e) Parish Gateways some research has been carried out into these and it is felt that at present they are financially unviable for this Parish.

## 23.03.05 Clerk Update

- a) Civility and Respect Pledge the councillors adopted NALC's Dignity at Work Policy in addition to the Code of Conduct already adopted 03.03.202.
- b) Elections the clerk has attended an online course in preparation for the upcoming local elections on 04.05.2023. In addition she will attend ESBC election briefing online on 07.03.2023. Information on becoming a parish councillor will be posted on the village notice boards. Nomination documents will be circulated by the clerk to anyone who requests one including existing councillors.
- c) Change of date for May meetings due to the elections and the Coronation the Annual meeting and the May Ordinary meeting will be held on Thursday 18.05.2023
- d) Mailing lists the clerk would like to create a comprehensive parish mailing list for emailing news briefings and other items of interest to residents. However there are still some email addresses which are held by the local neighbourhood watch representatives which are not on the parish mailing list. Due to data protection laws, these addresses cannot be shared. Residents who are not receiving emails directly from the parish council are to be asked to contact the parish clerk if they would like to be added to the parish email list.

- e) Replacement of Diamond Jubilee Oak which has died. This will be replaced when the saplings being grown by a local resident are ready to be planted.
- **23.03.06 Public** Participation. No members of the public were present.
- **23.03.07 Upgrade of Broadband in the Parish** nothing to report.
- **23.03.08 To receive oral report from Borough and County Councillors.** No councillors were present, however it was reported that Cllr Philip Atkins had been very helpful regarding the S59 signs on the B5013.
- **23.03.09 To receive Chairman's reports.** The Chairman is looking into ways we could use online banking. For ticket sales for the Coronation, it was agreed we would change the current account to read-only access.
- **23.03.10 To receive report from SPCO Tim Leathers.** A report has been uploaded to the website. Blithfield Reservoir remains a hotspot for anti-social behaviour. He feels the S59 signs are beginning to have an effect. He also patrols in an unmarked vehicle which is now know to the culprits who do largely disperse when he is around.

The Chairman had also contacted SPCO Tim Leathers regarding an incident on Newton Hurst Lane recently. He is concerned that full details of a violent attack had not been communicated to the Neighbourhood Watch in the area, and in particular, elderly residents living alone should be made aware of ways of making their property more secure and themselves safer.

**23.03.11 Speeding Cars and Motorbikes**. The S59 signs have now been installed, however the one in Abbotts Bromley Parish has been damaged. The County Council are currently looking into new materials which are harder to damage, for the replacement.
