234.01.02 Minutes of the Ordinary Meeting held on 02.11.2023 were circulated to the councillors in advance, approved and signed.

24.01.03 To receive declarations of interest by members in respect of items on the agenda. No declarations of interest were made.

24.01.04 Matters Arising from the Minutes

There were none.

24.01.05 Clerk Update

- a) Robert Pettiigrew, chief executive of the SPCA has been on sick leave for some time and the SPCA are experiencing some difficulty in delivering the service we have been used to, particularly answering queries. Members of the executive committee are helping where ever they can.
- b) An email of welcome and introduction has been sent to our new PCSO Chris Edwards.
- **24.01.06 Public Participation**. The subject of litter in the parish was raised. The clerk will look into litter picking support from the borough council, i.e. supply of bags, litter pickers, gloves and coordinated collection etc before the council launches a parish wide appeal for volunteers.
- **24.01.07 Upgrade of Broadband in the Parish** no further progress to report and problems in the Admaston area remain. Contact with BT suggested.
- **24.01.08** To receive oral report from Borough and County Councillors. No borough councillors were present however Cllr Jones had asked if a grant from the Ward Enhancement Programme would be of interest to us. This may be of use to the Village Hall, Cllr Kevin Massey will make the Village Hall committee aware.
- **24.01.09 To receive Chairman's reports** The Chairman continues to be concerned by speeding cars through the lanes of the parish. Hixon have a speed indicator sign (SID) at the entrance to Hixon from Lea Heath. It was agreed to make some enquiries about these including where they would be appropriate within our parish. Speed limits, SID positioning and road signage are to be the subject of a proposed meeting with appropriate county council highways officials. See 24.01.14.

There has been a spate of farm related crime involving livestock and theft in the parish and surrounding area. A resident of the parish has set up a Facebook group to help monitor this called Farm and Rural Community Watch Uttoxeter and Abbots Bromley. A meeting has been arranged at Admaston Village Hall on 17.01.2024 with a ranking police officer and the police and crime commissioner to discuss the issue. The parish council will have members attending.

24.01.11 Speeding Cars and Motorbikes. There continues to be a problem with cars using the Admaston lay-by to race to and then turn round and race back along the straight road to Rugeley. It is considered that the S59 signs have been very successful over the causeway but it would be useful if they could encompass the Admaston lay-by, as originally suggested by the residents. This would discourage the use of the lay-by for turning and waiting.

The clerk will make PCSO Edwards and highways officers aware and request action.

24.01.12 D-Day 80th Anniversary 6 June 2024. It was reported that the village hall committee were potentially happy to coordinate an event with the lighting of the beacon.

Advice has been received from SPCA that it would be a good idea for the parish council to have a meeting with Aura Power to confirm some key points, ahead of a public meeting, once the planning application has been made.

24.01.14 Highways and Lengthsman

- a) Steenwood Lane gullies complete
- b) Booth Lane Potholes the clerk has reported 3 potholes on Booth Lane
- c) The pothole on Newton Lane has been partially repaired, but further work by another 'team' is required.

The lengthsman reported that he had tidied around the memorial in Admaston and been round the parish clearing drains while there is a lull in the wet weather.

There is a sign on Watering Pit Corner which has been left in the long grass and not collected by the council. The clerk will ask for it to be moved.

Some of the wooden posts on School Lane, Admaston, which are there to protect the verge have been knocked down. Staffordshire County Council are to be asked to replace these.

There is extreme concern regarding the state of the road surfaces in the parish and the number of potholes. The roads are potentially hazardous, particularly to cyclists. The clerk is to write to the County Council, Highways department and ask for a meeting in the parish so that the problem can be discussed.
